A RESOLUTION OF THE FRESNO CITY COUNCIL APPROVING ACCEPTANCE OF GRANT FUNDS FROM THE CALIFORNIA DEPARTMENT OF HOUSING AND COMMUNITY DEVELOPMENT, HOUSING-RELATED PARKS PROGRAM (PROPOSITION 1C)

Parks, After School, Recreation and Community Services Department
Ted C. Will Community Center and Dickey Park Playground Improvements

WHEREAS, The California Department of Housing and Community Development (HCD) established the Housing-Related Park Program in accordance with (AB 2494, Caballero) Chapter 641, Statutes 2008 (hereinafter referred to as Prop 1C),

WHEREAS, the City of Fresno, Parks, After School, Recreation and Community Services (PARCS) Department applied for and was successfully awarded a grant in the amount of \$849,500 in Prop 1C funds; and

WHEREAS, said procedures established by HCD require the City of Fresno to certify by resolution acceptance of funds, and authorization for execution of documents; and

WHEREAS, the funds will be used in accordance with requirements established by the State of California Department of Housing and Community Development Housing-Related Park Program,

NOW, THEREFORE, BE IT RESOLVED THAT THE COUNCIL OF THE CITY OF FRESNO HEREBY:

1. Approve acceptance of \$849,500 in grant funding for the rehabilitation of the Ted C

Wills Community Center and Dickey Park Playground; and
