Pursuant to the agreement with the City of Fresno – Airports Administration office the fees are increased once a year on using the February Consumer Price Index (CPI) for the previous year and current year.

This fee is for all tee times at Airways Golf Course for Monthly Cards that are restricted to the individual named on the card. They are unlimited in play. They consist of Senior (unlimited, ID required), Junior (Unlimited, ID required), Frequent Players (no restriction on time of play) and Surcharges per round for each of the above and for Weekdays and Weekend/Holidays. Identification such as a driver's license or school photo ID is required. In the absence of a valid driver's license, another form of identification bearing a birth date may be submitted with prior approval from the Airways Golf Course. Pursuant to the agreement with the City of Fresno – Airports Administration office the fees are increased once a year on using the February Consumer Price Index (CPI) for the previous year and current year.
