A RESOLUTION OF THE COUNCIL OF THE CITY OF  
FRESNO, CALIFORNIA, ESTABLISHING DISTRICT 4  
TEMPORARY APPOINTMENT COMMITTEE

WHEREAS, Councilmember Larry Westerlund is currently representing District 4 and his term expires on the first Tuesday following the first Monday in January, 2009; and

WHEREAS, Councilmember Larry Westerlund is currently an officer in the Navy Reserves and has been called to active duty effective April 25, 2008; and

WHEREAS, Laws applicable to military service do not consider Councilmember Westerlund's position vacant but authorize the Council to select a temporary appointee for the remainder of Councilmember Westerlund's term or until he returns, whichever event occurs first; and

WHEREAS, Council believes it is in the best interest of the residents of Fresno and Council District 4 to have a temporary appointee to ensure continued District representation on all City issues; and

WHEREAS, it is the intent of the Council to create a committee for the purposes of interviewing eligible applicants, ranking their top five applicants, and summarizing the qualifications of all applicants to Council for Councilmember Westerlund's temporary replacement.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Fresno as follows:

1. District 4 Temporary Appointment Committee is hereby established.
2. The purpose of this Committee is to interview eligible applicants, rank their top five applicants, and to provide Council with summaries of the qualifications of all

applicants to serve as a Temporary District 4 Council appointee.

- 3. The Committee shall continue to exist until they have provided their ranking and written summaries to Council and Council has made a temporary appointment.
- 4. Membership shall consist of five members. They include Council President Xiong, Councilmember Larry Westerlund, Ruth Evans (Chamber Representative), John Hudson (Building Trades) and Janet Ryan (League of Women Voters).
- 5. The Committee shall be subject to the Brown Act and Public Records Act.
