

RESOLUTION NO. 2007 - 74

A RESOLUTION OF THE COUNCIL OF THE CITY OF FRESNO  
DECLARING ELECTION RESULTS



COMMUNITY FACILITIES DISTRICT NO. 2  
ANNEXATION NO. 133

WHEREAS, on February 27, 2007, the Council of the City of Fresno adopted Resolution No. 2007 - 73 calling a special mailed-ballot election on levying special taxes on land within, and on approving an annual appropriations limit for, Annexation No. 133 to Community Facilities District No. 2 ("Annexation No. 133"); and

WHEREAS, the Council has received, reviewed and hereby accepts the City Clerk's Canvass and Statement of Results of Election, dated February 27, 2007, a copy of which is attached as Exhibit "A";

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF FRESNO AS FOLLOWS:

1. The Council finds and declares that: (a) the ballot measure on the levy of taxes and approval of an annual appropriations limit for Annexation No. 133, has been submitted to the qualified electors within the area of Annexation No. 133, pursuant to Council Resolution No. 2007 - 72, and (b) the ballot measure has been passed and approved by more than two-thirds of the votes cast, in accordance with Government Code Sections 53326, 53327, 53327.5 and 53328(a).

2. The Council declares Annexation No. 133, to be fully formed and the property within Annexation No. 133, to be subject to the levy of the special taxes and the special tax lien described in Council Resolution No. 2007 - 72, annexing Final Tract No. 5424 as Annexation No. 133, and authorizing the levy of a special tax therein, Council Resolution No. 97-126, approving local goals and policies for Community Facilities Districts; and described in the Community Facilities District Report dated as of February 2, 2007 on file with the City Clerk.
