RESOLUTION NO. 2007-41

A RESOLUTION OF THE COUNCIL OF THE CITY OF FRESNO,
CALIFORNIA, DEDICATING CERTAIN CITY-OWNED PROPERTY
AS EASEMENTS FOR PUBLIC STREET PURPOSES AND PUBLIC PEDESTRIAN
WALKWAY PURPOSES



WHEREAS, the City of Fresno owns certain property located on the south side of East Butler Avenue west of South Chance Avenue, as shown on attached Exhibit "B"; and

WHEREAS, the subject property is being developed as Pump Station No. 61A in accordance with Conditional Use Permit No. C-06-133; and

WHEREAS, curb, gutter and sidewalk are required to be constructed across the frontage of the pump station; and

WHEREAS, the dedication of a 10 foot wide easement for public street purposes is required to conform to the right-of-way as proposed by the Butler Avenue Official Plan Line Serial No. 63 recorded April 14, 1967, in Volume 2 of Record of Official Plan Lines at Pages 78 through 82, Fresno County Records; and

WHEREAS, a driveway approach will be constructed along East Butler Avenue to provide access to the pump station; and

WHEREAS, a 2 foot wide pedestrian walkway easement must be dedicated at the back of the approach in order to comply with Federal ADA requirements, which requires a dedication

of City-owned property for public pedestrian walkway purposes to accommodate the approach.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF FRESNO AS FOLLOWS:

1. That certain portion of City-owned property described as Parcel "A" in attached Exhibit "A" and shown as Parcel "A" on attached Exhibit "B" is hereby dedicated as an easement and right-of-way for public street purposes.
2. That certain portion of City-owned property described as Parcel "B" in attached Exhibit "A" and shown as Parcel "B" on attached Exhibit "B" is hereby dedicated as an easement and right-of-way for public pedestrian walkway purposes.
3. Nothing contained in this resolution shall be deemed or interpreted by any party to cause any interest created in the public pursuant to this resolution to ripen into any title, interest or right of the public against or adverse to the rights of the City of Fresno nor shall this resolution limit, restrict or modify the exemption of public property to title by prescription as defined within California Civil Code Section 1007.
4. The City Clerk of the City of Fresno shall certify to the passage of this resolution and attest thereto under the seal of the City of Fresno.
5. The City Engineer shall cause a City deed number to be assigned to this resolution and shall cause this resolution to be recorded in the Office of the Recorder of the County of Fresno, California. The original resolution shall be returned to the City Clerk after recordation and a certified copy thereof shall be filed in the Public Works deed file.



E. BUTLER AVE.


