



RESOLUTION NO. 2007-227

A RESOLUTION OF THE COUNCIL OF THE CITY OF FRESNO,  
CALIFORNIA, APPROVING STREET NAME CHANGE APPLICATION  
NO. SNC-07-03

WHEREAS, in accordance with Section 12-1102 of the Fresno Municipal Code, Street Name Change Application No. SNC-07-03 has been filed by the City of Fresno, Planning and Development Department, to change the name of North Josephine Avenue to West Spruce Avenue, located within or near the neighborhood known as the Town of Herndon; and,

WHEREAS, in accordance with the provisions of the "Street Name Procedure" Ordinance, Article 11 of Chapter 12 of the Fresno Municipal Code, staff reviewed the requested change to an existing public street and recommended that the Fresno City Planning Commission support the applicant's request to change the street name of North Josephine Avenue to West Spruce Avenue, located within or near the neighborhood known as the Town of Herndon, given that these changes are not expected to create confusion amongst drivers, service vehicles, or emergency personnel; and,

WHEREAS, pursuant to the provisions of Section 12-1104 of the Fresno Municipal Code, the Planning Commission of the City of Fresno held a public hearing on June 6, 2007, to consider Street Name Change Application No. SNC-07-03 and related Environmental Assessment No. SNC-07-03, during which the Commission recommended to the Council of the City of Fresno approval of the subject environmental assessment and street name change application as recommended by staff; and,

WHEREAS, the Fresno City Council held a public hearing to consider Street Name Change Application No. SNC-07-03 on June 26, 2007.

NOW, THEREFORE, BE IT RESOLVED that the Council finds based upon its own independent judgment that there is no substantial evidence in the record that indicates Street Name Change Application No. SNC-07-03 may have a significant effect on the environment and hereby adopts the Finding of No Possibility of Significant Adverse Effect dated May 31, 2007.


