ELECTION

RECOMMENDATION

It is recommended that the Council adopt the attached Resolution declaring the results of the June 8, 2010 General Election.

EXECUTIVE SUMMARY

On July 15, 2010, the City Clerk's Office received from the County Clerk a certified abstract of the canvass of the results of the General Election held on June 8, 2010. Under the Elections Code, the Council must now declare the results of the election. An appropriate resolution has been prepared and is being presented for adoption.

BACKGROUND

The results of the General Election held on June 8, 2010, show that Blong Xiong and Clinton J. Olivier received over 50 percent of the votes cast within the City of Fresno and Measure A amending Section 1504 of the Charter of the City of Fresno relating to the addition of two Council Offices upon the City of Fresno's population reaching 650,000 received a majority of votes cast in support was declared adopted. Blong Xiong will continue serving his term as Councilmember for District 1 of the City of Fresno and Clinton J. Olivier will begin serving his term as Councilmember for District 7 of the City of Fresno upon administration of the oaths of office currently scheduled for January 6, 2011.

A RESOLUTION OF THE COUNCIL OF THE CITY OF FRESNO, CALIFORNIA,
DECLARING THE RESULTS OF THE CONSOLIDATED DIRECT PRIMARY
ELECTION HELD WITHIN THE CITY OF FRESNO ON JUNE 8, 2010

WHEREAS, On June 8, 2010, there was held in the City of Fresno, pursuant to Section 1400 of the Charter of the City of Fresno, a primary election; and

WHEREAS, the Council has met at the hour of 8:30 a.m. on July 22, 2010, at its usual place of meeting to declare the results of such election; and

WHEREAS, the County Clerk of Fresno County has canvassed the returns of the primary election and has prepared and presented to the Council a certified abstract of such returns setting forth the results of such election.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY OF FRESNO, as follows:

1. The certified statement of votes cast heretofore presented to this Council by the County Clerk of Fresno County is accepted and adopted as the official canvass of the returns of the June 8, 2010, primary election held in the City of Fresno, and the Council finds, determines, and declares the results of the returns of the election as follows:

(a) The whole number of votes cast in the City, the names of the persons voted for, the measures votes upon, for what office each person was voted for, and the number of votes given in the City to each person for and against the measure, are as set forth in this certified abstract, which is on file with the City Clerk and hereby made a part hereto as if fully set forth herein.

(b) The number of votes given at each precinct for and against the measure, and to each person is as set forth in the certified abstract referenced above.

(c) A general municipal election in November is required for Council District 3, and Council District 5.

2. **BLONG XIONG**, having received the majority of votes cast for the office of Councilmember for District 1, is hereby declared elected to that office.

3. **CLINTON J. OLIVIER** having received the majority of votes cast for the office of Councilmember for District 7, is hereby declared elected to that office.

4. **MEASURE A** - Amending Section 1504 of the Charter of the City of Fresno relating to the addition of two Council Offices upon the City of Fresno's population reaching 650,000 upon completion of a public review process, having received a majority of votes cast in support, is hereby declared adopted.
